Entry Restrictions	Open only to Australian residents aged 18 or over who hold a current driver's licence except directors, officers, management and employees (and the immediate families of directors, officers, management and employees) of the Promoter or any of its related entities, or of any Commonwealth, State, Territory or local government agencies or entities prohibited from receiving a prize, or of any agency or company associated with this promotion.

- (c) Clearly identify the continuous journey terminating at the Show N Shine.

Winner Determination

The Promoter will determine the winner of the Prize at 1:30pm on Wednesday, 20th September 2017 in Victoria.

The winner will be the Registered Entrant who has entered the Eligible Vehicle which has travelled the furthest in a single, continuous journey terminating at the Show N Shine (**Winning Journey**).

Notification of Winners

The name of the winner of the Prize will be announced at 1:30pm on Thursday, 21st September 2017 in Victoria, and the winner will be notified by email and telephone.

Prize Details

There is one (1) prize to be won.

The winner will be reimbursed for fuel used by the winning Eligible Vehicle while completing the Winning Journey to a maximum of \$2,500 (**Prize**).

The amount of the Prize will be equal to the actual cost of fuel used completing the Winning Journey, rounded up to the next highest AU\$100.

If the winner cannot provide reasonable evidence of the cost of the fuel used in the Winning Journey then the Promotor may determine a figure, in the Promotor's absolute discretion, which will constitute the Prize.

The Prize will not in any circumstance exceed AU\$2,500.00.

Proof of Purchase Requirements

Registered Entrants are required to obtain and retain proof of purchase for fuel used by an Eligible Vehicle during its journey to the Show N Shine for the purpose of calculating the value of the Prize.

1. Information regarding prizes and how to enter forms part of these conditions. By entering, entrants accept these conditions.
2. The promotion will be conducted during the Promotional Period.
3. Entries must be received during the Promotional Period. Entries are deemed to be received at the time they are received by the Promoter's database and not at the time of submission by the entrant. Failure of an entrant to provide their original itemised receipt/s to the Promoter upon request as per the Proof of Purchase Requirements may, at the Promoter's discretion, result in an invalid entry (and, at the Promoter's discretion, in all of the entrant's entries being invalid). The Promoter has no control over communications networks and is not liable for any problems associated with them due to traffic congestion, technical malfunction or otherwise. The Promoter is not liable for any consequences of user error including (without limitation) costs incurred.
4. The Promoter is not liable for late, lost, incomplete, misdirected, incorrectly submitted, delayed or illegible entries, correspondence or claims for prizes due to error, omission, tampering, theft, destruction or otherwise.
5. Any person meeting the criteria identified under Entry Restrictions and Entry Method may enter the promotion. Entry into the promotion is free of charge.
6. The winner will be determined at the time, on the date and at the location as stated under Winner Determination above.

8. The winners will be notified in accordance with the Notification of Winners section of these conditions.
9. The winner must, at the Promoter's request, participate in all promotional activity (such as publicity and photography) surrounding the winning of any prize, free of charge, and they consent to the Promoter using their name and image in promotional material.
